



WORK FOR THE EVENING

The work for the evening is a discussion of "The Future of Freemasonry", a report by the Social Issues Research Centre, which is, to quote its own website (http://sirc.org/), an independent, not-for-profit organisation based in Oxford, UK, which conducts research on a wide range of social topics and combines robust qualitative and quantitative methods with innovative analysis and thinking, and also conducts continuous monitoring of social and cultural trends.

The report has received a positive review from the United Grand Lodge of England. To quote from its website (http://www.freemasonrytoday.com/ugle-sgc/ugle/item/511-future-of-freemasonry-study-is-published):

"The Future of Freemasonry" report is the first ever independent study conducted by a non-Masonic body, and was commissioned as part of the build-up to the United Grand Lodge of England's tercentenary in 2017....

[T]he report suggests that, contrary to some misleading commentary, Freemasonry actually demonstrates genuine openness and transparency and it concludes that it is arguably more relevant today than ever before.

In particular, the report highlights that Freemasonry acts as a 'constant', providing members with a unique combination of friendship, belonging and structure, with many Masons saying they have made valuable lifelong friendships.

The report also highlights the importance that Freemasonry places on charitable giving, the part that many Freemasons play in their local communities and the central role of the family. As well as instilling in its members a moral and ethical approach to life – including thoughtfulness for others, kindness in the community, honesty in business, courtesy in society and fairness in all things – Freemasons are the largest charitable givers after the National Lottery, and also make major contributions to international disaster relief funds.

The role of ritual is shown to be an important part of Freemasonry for many members, with the report concluding that it provides both structure and familiarity, in just the same way as the normal rituals of daily life do for many people.

This article also appears on the website of *Freemasonry Today*, the official journal of the United Grand Lodge of England (http://www.freemasonrytoday.com/ugle-sgc/ugle/item/511-future-of-freemasonry-study-is-published). This URL also has a copy of the report itself, all 44 pages, or, if you prefer, I can email you a copy which I have gratefully received from W Bro Tony Pope.

I encourage you to read this report, or at least to browse through it, before our meeting in April. Attached to this email is an "economy edition", consisting of only 17 pages, sent to me by W Bro Tony Pope.

OUR DECEMBER AGM

At our February meeting, VW Bro Neil Morse gave an interesting talk entitled "1813 – What happened? Why is it important?" He, of course, spoke about the formation of the United Grand Lodge of England, which was formed from the union of the Premier Grand Lodge of England (sometimes referred to as the "moderns") and the Ancients' Grand Lodge of England, which took place on St John the Evangelist's Day, 27 December 1813. Neil used a number of documents and books to explain what happened and to give some background to this event. One of these books is John Belton's *The English Union of* 1813, published by Arima Publishing in October 2012. A couple of those present at the meeting already owned copies. Others wished to purchase copies and orders were taken. These books have arrived. Those who have not already received their copy from the Secretary can do so at our April meeting. If anyone else would like a copy, you can either order it directly from the Book Depository (the price is \$15.09) or inform the Secretary of the Linford Lodge of Research, who is prepared to make another bulk order.

FUTURE MEETINGS

The work for our May meeting is not determined. Any suggestions would be gratefully received. This will be discussed at our April meeting.



ANZMRC TRAVELLING LECTURER FOR 2013

At present it is uncertain when we will be hosting Bro Trevor Stewart, the ANZMRC Travelling Lecturer for 2013. There are two possibilities, viz. after his stay in Adelaide, which would be in early October, or sometime at the end of September, after he has given his talk in Sydney. The suggestion for early October came from an email sent on 6 March by the Secretary of ANZMRC in which it was stated that Bro Trevor Stewart would have two spells in NSW. As I am leaving Canberra today (6 May) and fly out of Sydney tomorrow for Scotland, I have asked the Secretary of the Discovery Lodge of Research to copy any emails to RW Bro Mike Dalton, one of our Deputy Preceptors. So, hopefully matters will be resolved soon. I hope to have access to the internet while away, but this will be on an intermittent basis. I return to Australia on 27 July 2013. Our Preceptor, VW Bro Neil Morse, should be back in Canberra in mid-June.

We also approached a private lodge for joint hosting of the meeting, which has worked well in the past. This lodge suggested that the meeting could be a Districts 103 and 104 sponsored event. This has not yet been resolved.

Aside from these uncertainties, it is almost certain that Bro Trevor Stewart will be visiting Canberra. I suggest that this should be an item for discussion at our July meeting. Do we want an open meeting? Do we want it to be a Districts event? Which of the talks offered would we like to hear Bro Trevor Stewart give? As W Bro Tony Pope has pointed out, this depends on the type of meeting we want to hold. If you want to know Tony's choices, contact either him or me!



DAVID SLATER'S TRAVELS

Last month's talk by our Preceptor on his travels overseas, including his presentation of a paper at the International Conference on the History of Freemasonry in Edinburgh, must have been a great success as I have been asked to give a summary of my overseas travels. I am sorry that I missed Neil's talk. I know that it must have been interesting because Neil indicated to me some of the places for masonic research that he had visited with recommendations that I should do the same. I did follow up on most of these suggestions and am very glad that I did.

For those of you who attended the Masonic Study Circles's meeting at the Mawson Club on Monday, 29 July, although some of the some material will be covered, it will be a different talk, with an emphasis of masonic research. There were two particular lines of research that I followed. One of these was to find out more of the masonic history of two of my wife, Marguerite's, relatives, viz. one of her great-great-greatgrandfathers and one of his sons. This involved looking up records in Scotland and in the Netherlands. I was unable to do much in Scotland but was more successful in the Netherlands where there is a great number of records covering Freemasonry in the Dutch East Indies. The second line of research was following up on the ciphered works of John Browne and William Finch produced at the turn of the nineteenth century. Copies of their works exist in Dublin and particularly in London. Neil also found some in Manchester, but I did not have time to go to that city. The library of the UGLE was particularly useful as it had some handwritten papers produced by an earlier decipherer of Browne's works. I will also give a report of my visit to a meeting of the Quatuor Coronati Lodge and some other lodges in Scotland, Ireland, Wales, England and the Netherlands

Time permitting, a short slideshow of various masonic related places that I attended on my European travels may be presented.



ANZMRC TRAVELLING LECTURER'S TALK

We chose the talk entitled *The HRDM—A Fourth Visitation to a Curious Eighteenth-Century Masonic Phenomenon from the North-Eastern Region of England* for W Bro Trevor Stewart's visit to Canberra. It was a very interesting talk which those present enjoyed. HRDM was a degree conducted in the north-east of England between the 1730 and 1810. Little detail is known about the ritual although Bro John Yarker has given a description of the manner in which the obligation and secrets were administered. It disappeared when the union between the Antients and the Moderns was being considered and there was a move to limit what was considered to be Pure Ancient Masonry. We thank Lodge Woden Valley for jointly hosting this talk,



OUR AUGUST MEETING

In August, Our Secretary gave an illustrated talk on his recent time overseas concentrating on masonic aspects of this trip, particularly the masonic research that he undertook. There were two areas of research. The first of these was to look up the masonic career of one of his wife's relatives who was a member of two lodges in the Dutch East Indies. He was able to do this through the records of the Dutch East Indies Lodges held at the *Cultureel Mason Maçonniek Centrum 'Prins Frederik* (CMC) in the Dutch city Den Haag..

The second area of research was to follow up on his research into John Browne's and William Finch's ciphered texts of masonic ritual, produced at the turn of the nineteenth century. This involved some research in the libraries at Freemasons' Hall in Dublin (at 17 Molesworth Street or Sráid Teach Laighean, if you prefer the Gaelic name) and at Freemasons' Hall, London (in Great Queen Street). At the latter were the handwritten findings of Bro E. H. Cartwright's deciphering of John Browne's *Master-Keys*, which is very useful in ascertaining how some of the errors in the published deciphered texts occurred.


